Upon consideration of the parties' Joint Motion for Stay, and for good cause shown, the motion is hereby GRANTED.

It is further ORDERED that:

- 1. The above-captioned case, is hereby STAYED for a period of 180 days from the date of this Order;
- 2. During the 180-day stay, the June 16, 2020, preliminary injunction and all subsequent orders issued (collectively, the "preliminary injunction") are hereby lifted and no party will be required to report to this Court or court liaison;
- 3. At the end of the 180-day period, upon Plaintiffs' filing of a dismissal with prejudice, the preliminary injunction will dissolve; and
- 4. In the event a dismissal is not filed and the case remains pending after the 180-day stay expires:
  - a. One-hundred-eighty days shall be added to each of the deadlines
     and dates in the Amended Pretrial Scheduling Order (January 13,

2021), which will resume its effect immediately; and

b. The parties shall file a joint status report to the Court within two weeks of the expiration of the stay.
