**PLAINTIFFS' MOTION FOR PRELIMINARY INJUNCTION
PURSUANT TO FEDERAL RULE OF CIVIL PROCEDURE 65(a)**

NOW COME the Plaintiffs in the above-captioned case, pursuant to Rule 65(a) of the Federal Rules of Civil Procedure and Local Civil Rule 65.1(b), and move the Court for a preliminary injunction against Defendant. In support thereof, Plaintiffs state as follows:

1. On March 12, 2013, Plaintiffs filed a Verified Complaint, alleging, pursuant to 42 U.S.C. § 1983, that Plaintiffs are entitled to relief from this Court for violations of their rights under the First and Fourteenth Amendments to the United States Constitution. The Verified Complaint also alleges that Plaintiffs are entitled to relief from this Court for violations of their rights under Article I, §§ 13 and 19 of the Constitution of North Carolina.

2. Plaintiffs seek a preliminary injunction enjoining Defendant, its officers, agents, affiliates, subsidiaries, servants, employees, successors, assigns, those persons in active concert or participation with Defendant, and all other persons within the scope of Federal Rule of Civil Procedure 65, from knowingly and/or intentionally delivering or allowing to be delivered sectarian prayers at meetings of the Rowan County Board of Commissioners.

3. Federal Rule of Civil Procedure 65 provides for the issuance of a preliminary injunction under circumstances such as those that exist in the present case.

4. In support of this motion, Plaintiffs submit a Memorandum of Law, addressing all necessary elements for the entry of a preliminary injunction, as well as affidavits from Plaintiffs Nancy Lund, Liesa Montag-Siegel, and Robert Voelker. Plaintiffs also submit the affidavit of Christopher A. Brook.

5. Plaintiffs seek leave to present oral argument in support of this Motion pursuant to Local Civil Rule 65.1(b).

WHEREFORE, for the foregoing reasons, and for those set forth in Plaintiffs' supporting Memorandum of Law, Plaintiffs respectfully move that the Court enter a preliminary injunction enjoining Defendant, its officers, agents, affiliates, subsidiaries, servants, employees, successors, assigns, those persons in active concert or participation with Defendant, and all other persons within the scope of Federal Rule of Civil Procedure 65, from knowingly and/or intentionally delivering or allowing to be delivered sectarian prayers at meetings of the Rowan County Board of Commissioners.
